## 1 INTRODUCTION, ATTENDEES AND APOLOGIES FOR ABSENCE

**Pauline Woods-Wilson** (President) opened the meeting at 16:30 and welcomed everyone, having conducted good housekeeping and explaining that the results of any votes are to be embargoed until 20:00, and confirmed that the meeting is quorate (there being more than 15 group members). Any technical outages would result in the in-person meeting deciding whether to continue or adjourn until another time. All speakers to confirm their names and membership designation.

She welcomed **Jen Cox**, Chair of Open Morris and **Peter Austin**, Bagman of the Morris Ring in person. **Jen Cox** and **Peter Austin** were acting as tellers for votes (both in the room and on Zoom). To facilitate the entering of votes in the room to the new voting system 'Cast Round' for those without a device to use the system, introductions were made to Voting Clerks **Jess Searle** (Member Communications Officer) and **Emma Laister**.

(The role of the Voting Clerk is to enter proxy, paper votes in the room and votes made by instruction by email in advance that were not added to 'Cast Round' either in advance or on the day by electronic means – these voting instructions were all handed to the clerks as the votes took place for them to action, these votes are counted in the totals of votes where shown; the role included checking for duplicate votes; a vote made at the meeting by the member representative themselves was taken in precedence to any advance vote, thus any alterations of vote due to the discussions were accounted for).

## 2 MINUTES OF THE PREVIOUS ANNUAL GENERAL MEETING & EGM

The minutes of the previous AGM meeting on 24<sup>th</sup> September 2022 were available in the AGM pack and also online at https://www.morrisfed.org.uk/agm/. These were taken as read.

**Fee Lock** (Mad Jack's) proposed them as correct, with **Shirley Dixon** (Jackstraws) seconding. These were approved 33 to 0 without amendment. **Pauline Woods-Wilson** (President) signed these as correct.

**Fee Lock** (Mad Jack's) proposed them as correct, with **Sally Wearing** (individual) seconding. These were approved 9 to 0 without amendment. **Pauline Woods-Wilson** (President) signed these as correct.

## 4 ANNUAL REPORTS

These had been previously circulated and taken as read. They are reproduced in Appendix 1 below.

# 4.1 Reports from Elected Officers:

# a) President

Pauline added — "Looking back, it has been a phenomenally busy year with all of our volunteers taking on extra work - our first grant from Arts Council England with exciting new videos being made (Esther Ferry-Kennington, Sally Smith, and Jenny Everett); new Safeguarding guidance (Drew), and all the guidance in the Members Manual now publicly available on the web (Pauline); the return of the FedExtra for reading online (Jess); 'Morris Matters' magazine and recorded videos of our zoom talks all searchable on the web site (Brian); launch of the 'Rattle Up my Boys' Longsword magazine archive online (Brian); two new research publications; more social media posts (Abigail) Throwback Thursdays and Tribute Tuesdays archive photos (Mike); the start of an Equality, Diversity and Inclusion panel of the JMO (Fee); and six extra JMO regional events for the 20th anniversary. Not to mention a completely revised Constitution (Jerry) and a new secure Voting system (Dan). And all this is on top of the 'run-of-the-mill' work that the Officers do.

There was a round of applause from the meeting for all the officers' efforts.

## b) Secretary

## c) Treasurer

The report was presented as in the AGM pack.

Shirley Dixon (Jackstraws) asked what the plan was for spending the money we have?

Jenny Everett (Treasurer) replied that this would targeted to projects that were yet to be identified; match funded for further expansions of the Arts Council grant funded project (to facilitate teaching of Morris in schools) or similar. Jerry West (Notation) added that the new constitution has a clause that requires excess

funds to be spent rather than retained in a bank account. Thus, the committee has to find ways to fund projects that fulfill its aims and objectives.

Diane Moody (New Esperance) asked about reducing reserves and whether we were just reducing the number on paper or our funds overall. There is a slight overall increase in income - expenses are reducing by using online meeting platforms resulting in less travel, and no postage for the FedExtra, meaning our available funds are increasing. Jerry West (Notation) replied that the reserves were a buffer to allow The Morris Federation time to recover from a year with low or very low income; this is set at £13,000 in the new Constitution, but funds over and above that could be used to promote Morris and for identified projects. Jenny also explained the original reserve level was set when a generic policy was put in place and this new level reflects more accurately the needs of The Morris Federation.

Accepting the report was proposed by **Diane Moody** (New Esperance) and seconded by **Fee Lock** (Mad Jack's) and carried - Votes For 35; Against 0.

# 5.1 MOTION 1 - Include Personal Accident Insurance with the Public Liability Insurance

The proposal is to include Personal Accident Insurance as a benefit to membership, within the current membership subscription rates at no extra cost to members for 2024.

Proposed by **Jenny Everett** (Treasurer) on behalf of the Committee, seconded by **Shrewsbury Morris** - Votes For 750; Against 76.

# 5.2 MOTION 2 - Adopt the revised Constitutional documents

The proposal is to replace our current Constitution and Standing Orders at <a href="https://www.morrisfed.org.uk/about/constitution/">https://www.morrisfed.org.uk/about/constitution/</a> by those included as Appendix 2 in the AGM Pack, to take effect after the end of the meeting. This motion required 2/3 of votes cast to be in favour.

Jerry West gave a short rundown on the rationale and consultations that had taken place in reaching these documents.

No questions asked from the floor.

Proposed by **Jerry West** (Notation Officer) on behalf of the Committee, seconded by **Sally Wearing** (individual) - Votes For 732; Against 20.

Thank you to all those who contributed to the Constitution Working Group, mostly Jerry West, some of the committee, and particularly: Sally Wearing, Val Parker, Bob Dunlop, Lesley Dunlop, Roger Kennington, Gunter Clasen, Shirley Dixon, and others.

## 6 DISCUSSIONS

No discussion items were notified by the deadline.

## 7 ELECTION OF COMMITTEE

As per clause 4 of the Constitution, committee members (officers) must stand for re-election every three years (in rotation). Officers can stand again.

#### 7.1 Treasurer

Jenny Everett, Treasurer since 2007, is standing down this year. This is a 3-year post starting 1st January 2024. No in-advance nominations were received. Pauline asked whether anyone in person or on Zoom would be willing to take this role on. On Zoom - Abbi Stephens (Wild Moon) volunteered after a short run through of the role from Jenny Everett (Treasurer), was proposed by Lin Steel (Enigma) seconded by Jerry West (Windsor) and was duly elected to the role - Votes For 437; Against 0.

### 7.2 Archive Officer

**Mike Everett**, Archive Officer since 2004, is standing down this year. This is a 3-year post starting 1<sup>st</sup> January 2024. Mike spoke about the role and the contents of the Archive. There were no volunteers for the role in the room or on Zoom.

It is proposed to draw together an Archive Group, as there have been some volunteers for helping with the archive, but none who felt that they could take on the full role.

**Peter Austin** (Bagman of the Morris Ring) told the meeting that the Morris Ring Archive was open to members to use if they wished to do so.

# 7.3 Membership Communications Officer

Jess Searle, Membership Communications Officer, is standing down at the end of the year, which is part way through her term. There are 2 years left to run. One Nomination has been received, for Eliza Russell (Worthing Larks) Proposer Worthing Larks and seconder Knights of King Ina.

A vote was taken - Votes For 721; Against 2.

Eliza Russell is therefore elected as Membership Communications Officer for 2 years from 1st January 2024.

For your information on other Committee posts ...

Under the 3-year tenure rule:

- Posts of Secretary and Notation Officer will expire on 31st December 2024 so they will be elected at next year's AGM, in 2024.
- Posts of President and Membership Communications Officer will expire on 31st December 2025 so will be elected at the AGM in 2025.

Note: We have several co-opted and advisor posts which are 1-year posts appointed by the Committee and renewable annually.

\* the exemption from the Licensing Act 2003 for Morris dancing (or any dancing of a similar nature) means that we don't need an entertainment licence to dance, and people who permit us to dance in public on their premises don't need an entertainment licence to provide us with dancing facilities

### 11 PRESENTATIONS AND VOTES OF THANKS

The first badge presented was to **Jenny Everett**, our Treasurer for 17 years, from 2007-2023. Which, in addition to her 4 years as Events Officer (1986-1989), makes a whopping 21 years. As well as her achievements noted in the AGM Pack, she:

- Sourced and stored the bells,
- Was always willing to fund worthwhile projects,
- Used to handle all renewals by hand (in the days when everyone used cheques!),
- Introduced external review of our annual accounts,
- Introduced and managed the transition to online banking,
- Found the best deals on bank interest and switched accounts long before "switching" was a thing,
- Created and ran the MF 'shop', managing all stock, taking orders by post, by email, by phone, wrapping parcels, stuffing envelopes and posting everything off,
- It's difficult to imagine just how much work all this was in the pre-internet era (and still is for the shop),
- And ... what we will miss the most ... is that she Is known for her timely, pragmatic and sensible
  advice on many contentious, and not so contentious issues the committee has faced during her
  time.

The second badge presented was to **Mike Everett**, our Archive Officer for a massive 20 years, from 2004-2023. As well as his achievements noted in the AGM Pack, he:

- Stored the physical archive and library (which comes in a several very large crates of material), copying and distributing documents as requested,
- Enthusiastic and dedicated to discovering archive material,
- Arranged for a photographic record to be made of all MF AGM days of dance,
- Created new material to celebrate anniversaries and other events (e.g. the 40<sup>th</sup> Anniversary CD),
- Collected ephemera for the archive (such as postcards) showing Morris dancing in a historical context,
- Worked with other archivists on projects of joint interest,
- Is known for his challenging questions and willingness to address difficult issues on behalf of the committee,
- And ... what we will miss the most ... his archive photos posted on social media for Throwback Thursdays and Tribute Tuesdays during lockdown, and beyond, to educate and engage our membership.

The third badge presented was to **Jess Searle**, our Membership Communications Officer for this year, 2023. As well as her achievements noted in the AGM Pack, she:

- Has been a bundle of enthusiasm and technical know-how,
- Stewarded at several JMO regional events,
- Been a great supporter of the Committee,
- And ... what we will miss the most ... her emotional support in times of stress.

We also presented badges to our hosts, **Martha Rhoden's Tuppenny Dish and Shropshire Bedlams**, and in particularly thanked **Poppy Horrocks** for doing the majority of the organizing for this event.

Some further thank you's to **Sam Ross** and **Dan Watford** for setting up and running the online part of this 'hybrid' meeting and to Dan Watford for developing our new electronic voting system 'Cast Round'.
